WHEREAS, we wish to recognize the untiring dedication and loyalty rendered by Chief Meehan during his 23 years of employment with the Township of Hazlet.

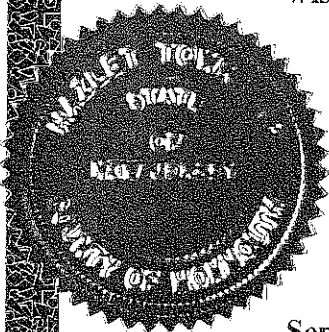
